1. **Students registered for full course must attend the classroom lessons (20 hours in the class) or online (digital) and 10 HOURS in the car with automatic transmission. 9 Hours home links (workbook.) 1 Hour survey/digital. Full attendance is mandatory. Two tests will be conducted in the classroom. In car test will be conducted at the end of the 10 Hours.**
2. You will be certified with the MTO once course is completed in full and student achieves a passing grade of 70% in both Inclass & In car.
3. After finishing the course student must advise the office in order to be certified.
4. **A \$30 will be charged for the certificate. It is not included in the course price.**
5. Extra lessons OR individual lessons must be paid by cash.
6. **Student must purchase the Saabi MTO Approved curriculum workbook. (Required by M.T.O) Cost is \$10 Including+Tax.**
7. All payments must be made mid way of the course. Administration fee (\$ 65.00 + GST) plus any services will apply if student does not want to continue course after enrolment with the MTO.
8. A \$55.00 fee will be applied for each dishonoured Cheque.
9. Appointments not cancelled within 24 hours notice will be charged fully to the students.
